The Managing Director, State Fisheries Development Corporation Limited, Bikash Bhawan, Bidhan Nagar, Kolkata-700091 invites off-line seal bid (as per prescribed format) from the eligible Co-operatives/Self Help Groups/Fish Production Groups/ Fish Traders/Fish Wholesalers /Fish Retailers /IndividualFarmers /Agencies(hereinafter isreferred as "THE BIDDER")for participating in Auction **for sale of marketable live Pangus fish (approx. quantity-1 ton)** at cage culture project, located at Kangsabati Reservoir, Bankura.

I. Auction details:

1. **Fish to be auctioned:** Live Pangus fish (above 500 gram)
2. **Site of Auction:** Office of the Assistant Director of Fisheries, Bankura.
3. **Approximate quantity of fish:** 1000 Kg.

V. Base Price: The base reserve price of Pangus fishes (> 500 gram) of 1 ton quantity to be auctioned is Rs. 90.00 per Kg. Increment value /price is Rs. 2.00 per kg.

LIVE AUCTION BIDDING METHODOLOGY:


- a. On the scheduled date of auction i.e. on **30.11.23**, auction will start at **1.00 p.m.** at the project site at Office of the Assistant Director of Fisheries, Bankura. Eligible bidder may participate at the auction. On the beginning of auction, participant should quote their bid at least with the base price mentioned above and may increase the price bid in accordance with increment value mentioned above. No bids shall be accepted after the time of bidding for Auction as mentioned.
- b. Any eligible bidder interested to participate in the auction can submit his bid(s) from date **30.11.23 from 1.00 pm to 2.00p.m.**

EVALUATION OF AUCTION:

- a. After completion of bidding, if it is found that the highest bid is more than or equal to the base price, fishes of Quantity-1 Ton i.e. 1000 kg as mentioned may be allotted to the highest bidder. The successful bidder needs to pay the advance amount of **Rs.50,000.00** amount within **30.11.23 or by latest 01.12.23 within 1.00 p.m** in the bank account (A/C No.-105605003538, IFSC Code-ICIC0001056, Name of the Bank Branch- ICICI Bank, Salt Lake, Sector V Branch) of this corporation or Demand Draft in favour of "THE STATE FISHERIES DEVELOPMENT CORPORATION LIMITED."
