NOTICE INVITING e-AUCTION SALE: SFDC/MD/NIT-37(e)/2023-24

Bids are hereby invited online by the Managing Director, The State Fisheries Development Corporation Limited on 'AS IS WHERE IS' and 'CAVEAT EMPTOR' basis from bonafide bidders/Cooperatives/Self Help Groups/Fish Production Groups/ Fish Traders/Fish Wholesalers /Fish Retailers /Individual Farmers /Agencies for sale of 20 ton marketable Pangus fishes (above 500 grams) from cage culture project site at Kangsabati Reservoir, Bankura.

 - Should not have been debarred by any Govt. Department or body/ Statutory organization/ PSU under the Govt. of West Bengal or the Central Govt.

Terms and conditions of Auction Sale

1. This e-auction will consist of two parts (1) Technical Proposal and (2) Live e-Auction
2. E-Auction bids are invited for getting sale price of the items listed in Table 1 on 'As is where is', 'No Complaint' and 'Caveat Emptor' basis only.
3. Participation and bidding by anyone in this sale shall be treated as conclusive evidence of the fact that the party has inspected the fishes offered for sale and satisfied himself in all respect regarding quantity, quality and other extraneous factor and principle of Caveat Emptor (let the buyer beware) will apply.
4. It shall be implied and taken for granted that the party has carefully gone through and understood the terms and conditions of e-Auction including the amendments, if any, prevailing at the time of bid. No complaints or objections shall be entertained by the authority after the bid is opened/accepted.
5. There should be at least three eligible bidders to start the e-Auction process. If the number of such bidders is less than three then the e-Auction process would be cancelled and the Earnest Money will be refunded.
6. If the highest bid in e-Auction is less than the reserve price the e-Auction shall be summarily cancelled and the security money /earnest money deposited will be refunded after the bid value is examined by the competent authority and found to be lower than the Reserve Price. The EMD of technically disqualified bidders will be refund on being disqualified.
7. The sale of fish would be made in favor of one successful bidder who has quoted the highest rate equal to or greater than the reserve price and who have been found to have fulfilled all the conditions of e-Auction Notice stated in this document.
8. The word successful bidder/ Buyer means a bidder whose rate has been accepted by the Auction accepting Authority.
9. **If the successful bidder fails to honor the bid then the security deposit / earnest money deposit shall be forfeited and he shall be barred from participation in all other auctions of SFDCL. Also, if any of the bidders having participated in the technical proposal fails to participate in the dynamic /live e-Auction the earnest money deposit may be forfeited.**
10. The intending bidders are requested to visit the Cage culture Project site at Kangsabati Reservoir, Bankura where the fishes to be auctioned are kept after intimating and obtaining information from the concerned Assistant Director of Fisheries, Bankura & or designated officials of ICAR-CIFRI regarding location of the auction items and inspect the such items. Bid may be submitted online after such inspection of the items to be auctioned. Expenditure incurred by a bidder for preparing bid documents and for inspection shall have to be borne by the bidder and no claim in this regard shall be entertained.
11. Auction inviting authority reserves the right to cancel the e-Auction at any stage and the authority inviting this auction shall not be liable to pay any compensation to any bidder for any loss that they may incur due to such cancellation.
12. Only courts in Kolkata shall have the jurisdiction for resolving any dispute arising out of this e-Auction.
13. In connection with any dispute arising out of this e-Auction, Arbitration will not be allowed. The dispute will first have to be laid before the forum specified in the dispute resolution mechanism prescribed by the Govt. of West Bengal. Bidders may peruse Finance Department MemoNo.8182-F(Y)dated26/09/2012.
14. Participation in the bid for buying the auction items of this e-Auction shall be treated as acceptance of all the terms & conditions as mentioned in this notice and also acceptance of all modalities as mentioned in this notice.
15. SFDCL shall not be responsible for any malfunctioning or non-functioning of any bidder's computer either on account of DSC (Digital Signature Certificate) or for any other reason Bids submitted by a bidder after signing with his/her DSC signifies non repudiation by the bidder. Thus, a bidder after submitting a bid cannot disown it. A bidder shall be fully and solely responsible for the bid recorded against his/her name to be identified by the set of User Id. Password and DSC.
16. Any amendment / addition to this auction terms and conditions will be made available in the online e-Auction portal as corrigendum.
17. SFDCL shall not be responsible for any kind of failure of network, internet and computer from bidder side etc.

18. During submission of bid, bidders are requested to follow the procedures according to the guidelines available in the e-Auction portal/website of NIC.
19. Terms and conditions as mentioned in this notice shall be a part of terms and conditions of the sale order /lifting order. Even if the terms and conditions as mentioned in this notice are not mentioned/enclosed with the lifting order the same shall be deemed to be included in the lifting order.
20. Earnest Money: EMD shall be submitted through Online / RTGS / NEFT in the ICICI bank.

21. Reserve Price:

There shall be a 'Reserve Price' for auction which will appear on the e-Auction portal at the time of auction. Bidders are required to bid for the rate per **kg** of Pangas fish to be auctioned. The Reserve price has been mentioned at column-3 of the Table-1 in para-1 of this e-Auction sale Notice. The Reserve price is the minimum amount from which the bidding shall start.

22. Auction Process:

- Uploading of signed scanned copies of documents(Technical proposal).
 - Uploading by Authority of the qualified list of bidders.
 - Live e-Auction.
 - Lifting order by the Authority and subsequent clearance by the successful Bidder of the Lot that is being put up for auction sale.
- a. Scanned copies of documents in PDF format need to be signed and uploaded.
- b. Approval by Authority: Scrutiny of documents and uploading of list of qualified bidders in the auction portal and thereafter only such qualified bidders will be able to participate in the live online auction.
- c. Live e-Auction bidding methodology : On the date of auction as mentioned in the table in Sl. No.4 of this e-Auction Notice, auction will start against the list of item mentioned in Table 1. Qualified bidders will be eligible to participate in the e-Auction. At the beginning of e-Auction the starting price shall appear. The incremental bid value should not be less than Re.0.50 per kg of the previous bid.
- d. Evaluation of the auction: After completion of bidding, the highest bid may be recommended by the Evaluation Committee without declaring the result. Thereafter, the procedure laid down in Finance Department Memo.4068F(Y) dated 25/05/2015 shall be followed.
- e. Competent authority will examine the rate offered by a bidder with respect to the reserve price fixed. The decision of the competent authority shall be final in respect of selection of the successful bidder.**
23. **Inspection:** The auction item listed in Table 1 may be inspected in their respective locations. The bidder shall lift the said items on 'as is where is', 'caveat emptor' and 'no complaint' basis. Any complaint from the buyer regarding any deficiency, etc. shall not be entertained.

24. Payment schedule(Related to successful Bidder):

- a. Successful bidder shall have to deposit in the bank account (A/C No.- 32567485120, IFSC Code-SBIN0007816, Name of the Bank Branch- SBI Bank, Bikash Bhawan Branch) of this corporation or Demand Draft in favour of "THE STATE FISHERIES DEVELOPMENT CORPORATION LTD" 50% of entire highest bid value of the full lot of 20 MT. fishes within 2 **days** from the date of issue of Letter of Acceptance. The remaining amount must be paid prior to completion of lifting of 10 MT of fishes.
- b. In case the successful bidder fails to deposit the requisite price of the bid within the stipulated time as mentioned above, the offer shall stand cancelled and the EMD shall be **forfeited**.
- c. All taxes/duties/levies, etc. and expenses including transportation and labour charge if any as applicable related to the item in the auction, shall be borne entirely by the successful bidder.
- d. The selected bidder will complete the lifting of the full lot of 20 MT fishes within 20 days of receipt of lifting order through e-mail or post, whichever is earlier.
- 25. Default in payment by the successful bidder:**
In addition to forfeiture of EMD, the defaulting bidder would not be allowed to take part in any e-Auction or any other auction of SFDCL which may be held in future.
26. In any case of dispute, decision of Auction Inviting Authority will be final and binding.

27. Bidders should submit the following documents (Technical Proposal) online by visiting the e-Auction Portal - <https://wbtenders.gov.in>:-
- a) Self Attested Pan Card/GST Registration Certificate, if applicable, and Trade License to be submitted. The self attested scanned copies of all documents shall be signed and uploaded online as indicated in the website.
 - b) Self Attested **Scanned copy of** notarized Power of Attorney in case of firm other than proprietorship firm, as per format(Refer Section–B for the format).
 - c) **Scanned copies of duly filled-up and duly signed copies of Forms and undertakings in Section-B of the e-Auction Notice**(Refer Section –B for the formats).
- EMD shall be submitted through **Online / RTGS / NEFT in the ICICI bank**. The earnest money deposit of disqualified bidders shall be refunded on being disqualified. The earnest money deposit of all bidders except the successful Bidder shall be refunded upon acceptance of the successful bid. Lifting order can only be issued to the successful bidder on completion of procedure laid down in the said Finance Department Memorandum No. 4068-F(Y)dated25/05/2015 and deposit of offered amount by the successful bidder. Any request for early refund of Demand Draft will not be entertained.
28. The earnest money deposited by the successful bidder will be refunded only after satisfactory completion of work certificate is furnished.
 29. A prospective bidder shall be allowed to participate in the e-Auction either in the capacity of individual or as a Partner of a firm. If found to have applied severally in the e-Auction, all his applications will be rejected for the e-Auction.
 30. Conditional/Incomplete bid will not be accepted under any circumstances.
 31. In case of ascertaining authority of intending bidders at any stage of auction process or lifting of auction items, necessary irrevocable power of attorney is to be produced as and when asked for by the authority who has issued the lifting order. In any case, power of attorney has to be submitted by the successful bidder at the Project site before lifting the auctioned items as only the power of attorney holder will be allowed to lift the auctioned items. However, in case of proprietorship Firm the proprietor of the firm shall be allowed to sign and receive/lift the auctioned items.
 32. The intending bidders must provide every detail of his name, address and Mobile no. and office land line number, clearly in the space provided for the same online. A **format (Form-Z)** is enclosed with this e-Auction Notice in section-B for the purpose which shall be duly filled-up, signed and uploaded and submitted online. Incomplete information may lead to rejection.
 33. Road challan and gate pass for transporting the auctioned items in pursuance to the lifting order will be issued on being provided information by the successful bidder in respect of truck registration number etc. on which such materials will be transported. However all other permits/permissions required for transportation and disposal will have to be arranged by the successful Bidder. All type of incidental costs have to be taken into consideration by the bidders while bidding.
 34. The successful bidder at his own cost has to adopt all safety/preventive/precautionary measures following relevant rules of the Government for safe disposal of all materials. Permission from appropriate authority if needed for such process has to be procured from the end of the bidder at his own cost failing which the earnest money of the bidder will be forfeited.
 35. All precautionary measures will be taken by the successful bidder who receives the lifting order so that no damage to any government property or personnel takes places. Under no circumstances measures which can cause a fire hazard will be permitted. Any damage or loss of Government/public/private property or life during the lifting process will be the sole responsibility of the successful bidder and the successful bidder has to defray the cost of such damage at his own cost as per estimate prepared by this office, failing which the earnest money of the bidder will be forfeited without any prejudice to the rights of SFDCL to take any other action as appropriate.
 36. The dates and times published on line are final and no request for any change will be entertained under any circumstances. Moreover, no objection in any form shall be entertained after completion of online scrutiny of documents.

37. A work completion certificate indicating, :”The works have been completed in all respects and the area has been cleared properly and no damage to any Government property has occurred during such process” must be obtained from the **Assistant Director of Fisheries, Bankura or Designated officials of CIFRI** and the same is to be produced to the MD, SFDCL before release of the earnest money of the successful bidder and which will be refunded without any interest irrespective of time required for completion of work.
38. The bidder shall assume all liability for and keep the Corporation indemnified against all actions or suits, claims, costs, damages, charges and expenses arising out of or in connection with the fulfillment of the terms and conditions of the auction sale, whether such actions, suits, or claims are brought by members of the public or workmen employed.
39. The auction inviting authority reserves the right to accept or reject any or all of the bids without assigning any reason thereof.
