  - The intending tenderers should produce credentials of a similar nature of completed work as a prime agency of the minimum value of 30% (thirty percent) of the estimated amount put to tender during 5 (five) years prior to the date of issue of the tender notice; or,

6. **No mobilization /secured advance shall be allowed.**  
Tender shall remain valid for a period not less than 180 (One hundred eighty) days after the dead line date for Financial tender submission. Tender valid for a shorter period shall be rejected by The Managing Director, as non-responsive.
7. **Transportation:** - The Transportation of materials from factory from outside or inside the state of West Bengal to the site of work is the sole responsibility of the bidder for manufacture of HPDE floating jetty. Statutory traffic restriction during transport of materials to the site of work is to be taken into consideration before submitting the tender.
8. **Test of samples:** -To verify quality, compliance, and durability in suitable environments, manufacturers and bidders must submit test certificates or physical samples evaluated by NABL-accredited labs or institutions:
- **Melt Flow Rate (MFR) / Melt Flow Index (MFI):** Tests the flow properties of the raw HDPE material to ensure structural integrity and uniform density.
  - **Density Test:** Verifies the specific density of polyethylene raw material to confirm grade purity.
  - **Tensile Strength & Elongation Test:** Measures how much stress the plastic or composite material can handle before breaking or stretching under wave and load actions.
  - **Environmental Stress Crack Resistance (ESCR):** Evaluates the longevity and resistance of HDPE cubes/pontoons against long-term exposure to weather, fuel, and saltwater.
  - **UV Stabilization & Thickness Verification:** Confirms that the outer shell has adequate UV inhibitors to prevent fading, cracking, or degrading under intense sunlight.
  - **Physical Load/Buoyancy Verification:** Practical physical check of modular block samples for buoyancy capacity, wall thickness uniformity, and interlocking lug strength.
9. **Warranty:** -The warranty / guarantee against the supplied items shall be given by the bidder for a period of **12 (twelve) months from the date of receipt of** HPDE floating jetty by the consignee. If any defect noticed within the above warranty/guarantee period the same shall be rectified/replaced from the nearest SERVICE Centre of beneficiary's site by the supplier at their cost and risk within 7(seven) days.
10. Proper demonstration should be arranged by the supplier.
11. **Arbitration Clause:** -Arbitration will not be allowed. The Clause No. 25 of 2911 is to be considered as deleted clause vide gazette notification no. 558/SPW-13th December, 2011.
12. Payment will be made after successfully completion of the work. No part payment will be allowed.

*1. General guidance for e-Tendering*

Instructions/ Guidelines for tenderers for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

**1. Registration of Contractor**

**2. Digital Signature certificate (DSC)**

Each contractor is required to obtain Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause-2 of Guideline to Bidder DSC is given as a USB e- Token.

3. The contractor can search & download NIT & Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

**4. Participation in more than one work**

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm.
